

**Islamorada Dolphin Tournament Rules:**

1. Entry fee shall be \$150.00 per angler or \$650.00 per boat if payment is received on or before 6-26-2015. \$175.00 per angler or \$750.00 per boat after 6-26-2015. To be eligible for Yamaha/Caribee largest fish prize you must be on an outboard powered boat and check the box below
2. This is a boat tournament and there is no limit on the number of participants per boat. All participants must sign an entry form. Except for licensed charter boats all persons on the boat must be registered. All fishing must take place on the registered boat. Substitution of a boat during the tournament must be approved by the rules committee. All participants are required to have the necessary licenses or permits.
3. No boat may leave the dock before 5AM. No transferring of fish or participants between boats is allowed.
4. All fish must be weighed in the presence of a registered participant who was on the boat the day it was caught. All fish must be weighed on the day it was caught. Fish must be in fresh, edible condition and caught on rod and reel. No mutilated fish. All participants are encouraged to release fish not to be entered into the tournament. Fish may be subject to inspection by Torry meter. Any fish may be cut open. If a fish is determined to be unacceptable by the tournament committee it will eliminate the boat from the tournament.
5. Only two fish can be weighed each day. The combined weight of three fish shall determine the winners. In the event of a tie the boat weighing in first shall be the winner. Weigh scale will close at 5:00 each day. The awards ceremony shall be immediately following the final day of weigh-in at Smugglers Cove Restaurant and Marina.
6. Captains are ultimately responsible for their crew and should make decisions as to safe sea conditions for their vessel.
